Some of these ideas hold solid promise and need to be tried in real world farm situations. Ag Solutions does not currently have the resources to drive such an initiative so Jim Keller met with the County Commissioners to seek help. He suggested an individual be hired by the county to work with farmers to investigate and hopefully implement one or more of these ideas. Due to the expense, his request was turned down so Ag Solutions will need to approach this challenge in another manner.
